## 6. **INFORMATION/COMMITTEE REPORTS**

6.A. General Manager's Report

The General Manager highlighted the attached influent flow chart and explained when there is high flow the inflow and infiltration (I&I) increases which affects the variable rate for each Member Agency. I&I is when water, other than wastewater, enters the sewer system.

The Governing Board asked the difference between the flow table in the report and the attached influent flow chart.

## 6.B. Replenish Big Bear Report

The General Manager highlighted the expenditure table and the letter from the Santa Ana Regional Water Quality Control Board advising of a complete Report of Waste Discharge application. The letter has been sent to the Big Bear Municipal Water District (MWD) and is one of the items MWD needed before considering an agreement.

The Governing Board asked if the Santa Ana Regional Board has been inundated with applications for water reclamation projects. The Governing Board clarified the Program Water quantity.

Joyce Crist commented that the people of Big Bear Lake do not want the water in the lake and believes the Forest Service should determine the quality of the water being put back into the watershed.

The Governing Board clarified that Big Bear is part of the Santa Ana system for the Santa Ana Regional Water Quality Control Board.

## 9. <u>OLD BUSINESS</u>

## 9.A. Replenish Big Bear Discussion

The Administrative Services Manager/Board Secretary presented additional information about the advisory vote, formation of a Community Facilities District/Mello-Roos tax, and a public opinion poll. Per the San Bernardino County Registrar of Voters, a JPA cannot put an advisory vote on the ballot; therefore, this is no longer an option.

The Governing Board adjourned at 5:38 p.m. and reconvened at 5:48 p.m.

Matt Scriven commented about elected officials making decisions about this generational infrastructure project that Big Bear Valley needs. There is a lot of confusion about who is paying and why.

Joyce Crist commented how raising taxes will impact her, and the Big Bear City Community Services District area has a different interest than the people in Big Bear Lake.

The Governing Board commented that the Community Facilities District (CFD) or Mello-Roos tax is an unfair method of taxation because not everyone and not all property owners get to vote on it. The Governing Board further clarified voting eligibility for a CFD; the differences between fees, assessments, and special taxes; and if the Taxpayer Protection Act would affect any decisions for Replenish Big Bear. Additional discussion included the differences between the information provided by Member Agencies for their respective Prop 218 protest hearing notices, and the cost and duration of rates for Replenish Big Bear being unclear in those notices.

The Governing Board inquired how equivalent dwelling units (EDUs) are computed year to year, how the 500 acre feet per year in the Letter of Intent was established, clarified that the Replenish Big Bear Program involves multiple projects with the first project filtering the water and sending it to Big Bear Lake, expressed concern over the cost to send water to Sand Canyon for recharge, and questioned if the cost of Replenish Big Bear was fiscally responsible and if it benefits the entire Big Bear Valley. Further discussion included the timeline for when project funds are expended, when the WIFIA loan needed to be in place, the certification of the draft Program Environmental Impact Report, the items that can be moved forward when the certification is complete, and the cost to complete the construction plans. The Governing Board discussed a contract clause to allow for use of additional Program Water for groundwater recharge in the future.

The Governing Board would like to continue the discussion of Program Water equity and directed staff to bring back poll information at the May regular meeting.

#### **10.A.** Pay Schedule

The General Manager explained the COLA (cost of living adjustment) was included in the approved budget for the Governing Board's consideration. The Governing Board requested an updated Organizational Chart. Upon motion by Director Walsh, seconded by Director Russo and carried, the Governing Board approved the publicly available Pay Schedule effective July 13, 2024.
